### Head of Computer Science

#### Job Purpose

To deliver high-quality Computer Science teaching, inspiring and empowering Holme Grange pupils to achieve their best. This role also offers the opportunity to lead the Computer Science Department, ensuring outstanding teaching and learning while fostering a dynamic and innovative learning environment. The position provides an excellent opportunity for a passionate teacher to develop leadership skills and shape the future of Computer Science at Holme Grange School.

#### Teaching Responsibilities

All teachers at Holme Grange are expected to contribute fully to the extra-curricular and pastoral life of the school, including serving as form tutors. As tutors, teachers oversee the academic and pastoral welfare of a group of pupils, liaising with parents and staff to support student progress. Teachers also engage in school-wide activities such as coaching sports, directing plays, supporting clubs, and organising trips.

Teachers at Holme Grange are expected to:

- Participate in school events, open days, and promotional activities related to the subject area.
- Collaborate with colleagues to enhance the curriculum and share best practices.

- Organise and lead departmental meetings, training sessions, and professional development initiatives.

### Pastoral & Extra-Curricular Engagement

- Promote opportunities for active citizenship, leadership, and student engagement in business-related initiatives.
- Maintain effective communication with parents, colleagues, and external stakeholders.
- Actively contribute to the school's wider pastoral and co-curricular programme.
